AN ACT

To appropriate the sum of \$43,375.00 supplemental funds for fiscal year 2010 of Koror State Government special projects and programs and for related purposes.

THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:

1 **Section 1. Short Title.** This Act may be cited as "Koror State FY 2010
2 Supplemental Budget Act."

3 **Section 2. Appropriation.** The sum of \$43,375.00 is hereby appropriated
4 to supplement expenditures and obligations in Fiscal Year 2010 from Koror State
5 Treasury to the budget activity as set forth below, and more specifically itemized in the
6 attached Schedule A which is incorporated herein by reference.

7 **Section 3. Revenue Sources.** The entire sum of \$43,375.00 herein
8 appropriated for Koror State FY 2010 Supplemental Budget shall come from RPPL No.
9 8-15 National Supplemental Budget Act of 2010 National Block Grant appropriations
10 as identified in the attached Schedule B.

11 **Section 4. State's Programs and Special Projects.** The sum of \$43,375.00
12 is hereby appropriated for expenditures and obligations for Fiscal Year 2010 as
13 supplemental fund to continue special programs and projects. The sum hereunder shall
14 come from the National Appropriations. The Governor is authorized to reprogram
15 funds from one item to another but not to exceed 15% of the total amount apportioned
16 for the item which the funds are moved.

19 **Section 5. Severability.** If any part or provision of this Act is determined to
20 be unlawful or invalid, such invalidity may be stricken and shall not affect the other
21 provisions of this Act.


1 **Section 6. Effective Date.** This Act shall take effect upon its becoming law
