

<p><b>Rock Island Permit and Jellyfish Lake Permit</b></p> <p><b>Koror State Law: Rock Island Management &amp; Conservation Act K8-207-2009</b></p> <p><b>Amendments: K8-209-09; K9-245-2011; K9-248-2011</b></p> 	<p>2009</p> <p>2011</p>	<p>The <i>Rock Island Use Permit</i> must be purchased for a fee of <b>\$50.00</b> for all visitors who are <b>6 years old and above</b>. The <i>Jellyfish Lake Permit</i> must be purchased for a fee of <b>\$100.00</b> for all visitors who are <b>6 years old and above</b>. A valid <i>Rock Island Use Permit</i> allows per visitor entry and access to any areas specifically designated as a tourist activity area in the Rock Islands Southern Lagoon, <b>excluding</b> Jellyfish Lake (Ongeim'l Tketau). A <i>Jellyfish Lake Permit</i> allows per visitor entry and access to any areas specifically designated as a tourist activity area in the Rock Islands Southern Lagoon, <b>including</b> Jellyfish Lake (Ongeim'l Tketau). A visitor who already possesses a valid Rock Island Permit who chooses to access Jellyfish Lake (Ongeim'l Tketau) may be issued a voucher at the Jellyfish Lake Rangers' Outpost at an additional fee of <b>\$75.00</b>. This fee must be paid at the Koror State Finance Office within <b>48 hours</b>. In this instance, the subject permit shall be upgraded to a Jellyfish Lake Permit for the remaining duration of the permit.</p> <p>All Use Permit fees must be paid payable to the Koror State Government at any of the two designated locations, the Koror State capitol building Finance Office in Ngerbeched Hamlet, and the Malakal Finance Field Office at the Rangers Station, Malakal area. A permit purchased is valid for a period of <b>10 days only</b>. A valid permit is non-transferable and non-refundable. A valid permit in a sequential number must be completely filled out with the following required information:</p> <ul style="list-style-type: none"> <li>• Name of Tour Company and or Operator</li> <li>• Printed name of a visitor as show on the visitor's passport</li> <li>• Visitor's signature</li> <li>• Date and Expiration of the permit</li> </ul> <p>Absence of any of the stated information will deem the permit invalid. Permits must be made available for inspection by Koror State law enforcement personnel upon demand. <b>Incomplete, transferred, counterfeited, duplicated, forged, altered or created permit by any other entity other than Koror State Government will deem the permit invalid.</b></p>
		<p>All boat operators and or tour guides must possess a tour passenger list, for all passengers on a given tour. Subject list must be readily available for inspection by Koror State Enforcement Personnel. The passenger list or manifest must contain the following information:</p> <ul style="list-style-type: none"> <li>• Name of each visitor as shown on visitor's passport in Roman Alphabet</li> <li>• Name of the visitor's country of origin</li> <li>• The visitor's date of arrival and departure</li> <li>• Individual permit numbers</li> </ul> <p><b>Failure to provide this list upon inspection is a direct violation of the law.</b></p>
