## AN ACT

To repeal Section 1 (2) of KSPL No. K4-66-94 and to establish the annual salary payable to the Governor and to the department heads of Koror State Government; to repeal Section 14 of

KSPL No. K5-73-96 and to establish the monthly honorarium and per meeting honorarium payable to members of the House of Traditional Leaders of Koror State Government; to repeal KSPL No K3-40-89 and 10 KSC 301 and to establish monthly and per meeting compensation for members of Koror State Legislature; and for related purposes.

THE PEOPLE OF THE STATE OF KOROR REPRESENTED IN THE STATE LEGISLATURE DO ENACT AS FOLLOWS

Section 1. Repeal of Section 1 (2) OF KSPL NO. K4-66-94; to establish salary for the Governor and to the Department Heads. Section 1 (2) of KSPL No. K4-66-94 is hereby

repealed, and the annual salary payable to the Governor and to the department heads shall

be established as follows:

- A. The Governor of the State of Koror shall receive an annual salary of \$28,000.00 per annum: payable bi-weekly in 26 equal installments; and
- B. Department heads of Koror State Government shall receive an annual salary of \$18,000 per annum payable bi-weekly in 26 equal installments.
- Section 2. Repeal of Section 14 of KSPL No K5-73-96 and establishment of monthly honorariums and per meeting honorarium payable to members of the House of Traditional Leaders of Koror State Government.
- A. Section 14 of KSPL No K5-73-96 and KSPL No. K3-38-89 are hereby repealed, and

the monthly honorariums payable to the members of the House of Traditional Leaders shall

be established as follows: Ibedul - \$600.00, Ngarameketii - \$400.00, Rubekul-Kldeu -

\$375.00, payable on or before the fifteenth (15th) and thirtieth (30th) of each

month. The

honorarium payable to the members of the House of Traditional Leaders shall only be paid to

the person who actually holds a title and sits as a member of the House of Traditional Leaders.

B. In addition to the honorarium mentioned above, each member of the House of Traditional Leaders shall be paid \$25.00 for each day when attending a meeting of the House of Traditional Leaders.

Section 3. Repeal of KSPL No K3-40-89 and 10 KSC 301; establishment of the monthly and per meeting compensation for members of the Legislature.

A. Koror Public Law No. K3-40-89 and 10 KSC 301 are hereby repealed,

and the monthly compensation payable to the members of the Legislature shall

be \$375.00 payable on the fifteenth (15th) and the thirtieth (30th) day of each

month.

B. In addition to the compensation mentioned above, each member of

the Legislature shall be paid \$25.00 for each day when attending legislative

session.

Section 4. Severability. In the event that a court of competent

jurisdiction

determines that any part or portion of this law is invalid, then the offending

portion or

portions may be stricken, and the remaining portions shall continue in full

force and effect.

Section 5. Effective date. This Act shall become effective on January 13,

1998.
