

**AN ACT**

To amend Koror State Public Law No. K5-85-97 to provide for an increase in annual salary payable to the department heads of Koror State Government and for related purposes.

**THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:**

1           **SECTION 1. FINDINGS.** The Seventh Koror State Legislature hereby finds that the  
2 Department Heads of Koror State Government have been receiving \$18,000.00 per annum  
3 since 1997 with no increase. It is in the best interest of the people of the state of Koror to  
4 allow department heads appointed by the elected governor and confirmed by the legislature  
5 to receive fair and adequate consideration for the services provided to the state.

6           **SECTION 2. AMENDMENT OF SECTION 1 (B) OF KSPL NO. K5-85-97 TO**  
7 **INCREASE SALARIES FOR THE DEPARTMENT HEADS.**

8           A. Section 1 (B) of Koror State Public Law No. K5-85-97 is hereby amended to read as  
9 follows:

10                           “B. Department heads of the Koror State Government shall  
11                           receive an annual salary ranging from \$22,000 to \$28,000 per  
12                           annum payable bi-weekly in 26 equal installments.”

13           **SECTION 3. SEVERABILITY.** In the event that a court of competent jurisdiction  
14 determines that any part or portion of this Act are invalid or otherwise unenforceable, then the  
15 offending part or portions may be stricken, and the remaining portions shall continue in full force  
16 and effect.

17           **SECTION 4. EFFECTIVE DATE.** This Act shall take effect on January 1, 2006, upon its  
18 becoming law by operation of the Koor State Constitution.
