AN ACT

To amend KSPL No. K6-113-2000, as amended by KSPL No. K6-126-2001, to increase the amount of the fee for use of tourist activity areas, to require a separate permit and the payment of a \$35.00 fee for persons to enter Jellyfish Lake on Macharchar Island, to provide for the use of fees collected, to regulate activities in and to prohibit entry to jellyfish lakes, and for related purposes.

THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:

SECTION 1. FINDINGS.

The Eighth Koror State Legislature hereby finds that "Jellyfish Lake", located in Macharchar Island, is a unique, natural eco-system that has evolved undisturbed for the last 10,000 to 5,000 years. In recent years, tourism has increased the number of visitors to the lake, and steps need to be taken to preserve the lake in its natural condition to the greatest extent possible, or else the unique natural beauty may be lost for future generations. Affirmative steps need to be taken to preserve this lake as one of the unique natural wonders of the world.

9 Each year, approximately 70,000 to 80,000 tourists come to Palau, and most of 10 the tourists visit the rock islands, with a significant number of tourists swimming in 11 Jellyfish Lake. In recent months, as many as 200 to 300 tourists have visited the lake on a 12 daily basis. These large numbers of visitors have a significant impact on the natural 13 ecosystem.

One problem associated with the high number of visitors to the lake is the potential introduction of "invasive" and non-native species, or species that are not natural to the lake as it has developed over thousands of years. Most of these invaders are found at or near the swimming "entry" dock at the lake, suggesting that they are being brought in by visitors; Swimmers in the lake may also use sun screen or other lotions, which may also have a negative impact and add to the stress on the delicate marine life. All of these

Page 1 of 19 20 impacts will have a negative effect on the lake and the jellyfish populations, unless 21 measures are taken to

1	prevent and detect invasive and non-native species, and to limit the number of visitors.
2	By increasing fees, those persons who are truly interested in observing the
3	jellyfish should be willing to pay the increased fee, and to pay for increased protection for
4	the lakes, and the expected decrease in the number of visitors will provide for a higher
5	quality visit and a more memorable experience.
6	T he increasing number of visitors to the rock islands is also placing a strain on
7	Koror State resources for maintaining and up keeping the rock island and guest facilities,
8	and an increase in the rock island use permit fees will help Koror State to adequately
9	clean and maintain tourist activity areas and other areas of the rock islands.
10	It is in the best interests of the people of the State of Koror to provide for a
11	separate permit, and a separate fee of \$35.00, to decrease the number of visitors and to
12	increase the quality of a visit to Jellyfish Lake, and to allow Koror State to generate
13	revenues that may be used to monitor and preserve the marine life in the lake. It is also in
14	the best interests of the people of Koror to increase the fee for the general tourist activity
15	permit, so that Koror State can take affirmative steps to monitor and improve the quality of
16	the rock island experience.

16	and are not transferable, and the Jellyfish Lake permit shall
17	include the privileges of a Rock Island Use Permit and shall
18	allow tourists to enter all Tourist Activity Areas. The
19	Jellyfish Lake permit shall be kept in the tourists possession
20	and control at all times, and must be produced upon
21	disembarkation at the dock for Jellyfish Lake, and before
22	entering Jellyfish Lake, or upon demand by Koror State law
23	enforcement personnel. The boat operator or Tour Operator
24	may hold the permit while the tourists are visiting the
25	Jellyfish Lake. Koror State Government shall post a person

12	issued permit and only a valid permit issued by the State of
13	Koror shall be deemed lawful under this Act.

22	carried with the official guests at all times while in the Rock
23	Islands. Such grant of exemption shall not exempt the
24	official guest, Palauan, or Resident Alien from any
25	requirements or prohibitions of this Act, or any other law,

4	SECTION 11. PROHIBITION AGAINST ENTRY TO OTHER
5	JELLYFISH LAKES.
6	A. It shall be unlawful to enter or to come within two-hundred feet (200') of any
7	other marine lake with jellyfish in Koror. "Marine Lake" means any body of water that
8	contains salt water, and which appears to be landlocked, but which is connected to the sea
9	by fissures, cracks, caves, or tunnels.
10	B. It shall be unlawful to aid, abet, encourage, assist, guide, escort, or otherwise
11	take any person regardless of citizenship or immigration status to any jellyfish lake in
12	violation of the prohibitions of this section.
13	C. The Governor may provide a written exemption from the prohibitions of this
14	section for any scientific, educational, or environmental activity, or to any other person in
15	the discretion of the Governor. The exemption shall state the name of the persons
16	exempted, and the dates of exemption.
17	SECTION 12. PROHIBITIONS WHILE IN JELLYFISH LAKES.
18	A. It shall be unlawful to take, remove, capture, or otherwise possess any marine
19	life, including but not limited to jellyfish, from any jellyfish lake.
20	B. It shall be unlawful to wear gloves while in any jellyfish lake.
21	C. It shall be unlawful to bring any living or non-living organism into any jellyfish
22	lake, and no living or non-living organisms may be introduced or otherwise released into
23	any jellyfish lake. This prohibition includes, shells, corals, rocks, fish, crabs, vertebrates,
24	invertebrates, and pieces of any organism, living or dead.
25	D. The prohibitions of this section apply to the jellyfish lake on Mecherchar Island,
26	Page 17 of 19 and the jellyfish lake on Ngermeuangel Island, and to any other marine lake with jellyfish.
27	E. It shall be unlawful to aid, abet, encourage, assist, guide, escort, or otherwise

3	F. The Governor may provide a written exemption from the prohibitions of
4	subsections "A." and "B." herein for any scientific, educational, or environmental activity,
5	or to any other person in the discretion of the Governor. The exemption shall state the
6	name of the persons exempted, and the dates of exemption.
7	SECTION 13. SEVERABILITY.
8	The provisions of this Act are severable. If any part or portion of this Act is held to
9	be invalid or unenforceable, then the offending portions may be stricken and the remaining
10	portions shall continue in full force and effect.
11	SECTION 14. EFFECTIVE DATE.
12	This Act shall become effective upon its becoming law of the State of Koror by operation
13	of the Koror State constitution, except that Section 3 (Jellyfish Lake permit and fee
14	requirement) shall become effective beginning on April 1, 2007.
