A BILL FOR AN ACT

To amend the Koror State Zoning Map for areas in Meyuns along Rael Kabesang, beginning at the north end of Didall, through Meyuns, to the vicinity of Bai ra Edib, and for related purposes.

The Eighth Koror State Legislature hereby finds that the Koror State Zoning Map, as described in former 31 PNC 3004, now adopted as law of the State of Koror, is the official map of the boundaries of all land use zones in Koror. The official Zoning Map may be amended by the Legislature, after request by the Koror Planning Commission.

The Koror Planning Commission has written to the Legislature seeking to amend the Koror Zoning Map for areas along the main road in Meyuns. The areas are currently zoned "RI", or single family, low density housing. There has been much commercial development along the main road, and the increased demand for housing justifies higher density, multiple family housing. A public hearing was held in Meyuns, and there were no objections to the proposed amendments.

SECTION 2. AMENDMENT OF KOROR ZONING MAP.

A. The Koror Zoning Map is hereby amended for the following described parcels of land:

Cadastral Lots No. 009 A 01, 009 A 02, 009 A 03, 009 A 04, 009 A 05, 008 A 06, 008 A 07, 008 A 08, 008 A 09, and 008 A 11.

These parcels of land are hereby rezoned from "R-1", Single Family Residential zone, to "RC" Residential Commercial zone.
