

AN ACT

To authorize and appropriate supplemental funds for fiscal year 2008 operations and for related purposes.

THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:

1 **Section 1. Short Title.** This Act may be cited as "Koror State FY 2008
2 Supplemental Budget Act."

3 **Section 2. Appropriation.** The sum of \$284,460.00 is hereby authorized and
4 appropriated for expenditures and obligations in Fiscal Year 2008 from Koror State Treasury to
5 the budget activities as set forth below, and more specifically itemized in the attached Schedule
6 A which is incorporated herein by reference.

7 **Section 3. Revenue Sources.** The entire sum of \$284,460.00 herein authorized and
8 appropriated for Koror State FY 2008 Supplemental Budget shall come from State's local
9 revenues as identified in the attached Schedule B. If collections exceed projected revenues, all
10 such excess collections shall remain in the Koror State Treasury until authorized and
11 appropriated by law.

12 **Section 4. Executive Branch.** The sum of \$284,460.00 is hereby authorized and
13 appropriated for expenditures and obligations for Fiscal Year 2008 to cover operational and
14 contingent expenses of the Executive Branch. The Governor is authorized to reprogram funds
15 from one item to another but not to exceed 15% of the total amount apportioned for the item
16 which the funds are moved, except for the funding for the Planning Commission appearing in
17 subsection "f." herein below, which funds may not be reprogrammed. The total amount
18 appropriated shall be apportioned and allotted at the direction of the Governor and shall be
19 allocated according to the following schedule:

20	a. Dept. of Treasury-----	\$ 27,000.00
21	b. Dept. of Law Enforcement -----	\$ 65,000.00
22	c. Jelly Fish Lake Landing (outside) -----	\$ 17,000.00
23	d. Hamlet Street Lights-----	\$135,000.00
24	e. FAD Deployment-----	\$ 10,460.00
25	f. Planning Commission-----	\$ 30,000.00

1 Sub-total ----- \$ 284,460.00

2 Section 5. **Severability.** If any part or provision of this Act is determined to be
3 unlawful or invalid, such invalidity may be stricken and shall not affect the other provisions of
4 this Act.

5 Section 6. **Effective Date.** This Act shall take effect upon its becoming law by
6 operation of the Koror State Constitution.
