

**AN ACT**

To authorize and appropriate \$72,000.00 as supplemental funding for fiscal year 2008 as additional funding to be used by the *Committee on The Silver Anniversary of Koror State Constitution* established by Executive Order No. 08-03; to be used to pay overtime for State employees for the Silver Anniversary activities; and to pay for legislative travel expenses for the 2008 Fiduciary Conference; and for related purposes.

THE PEOPLE OF KOROR REPRESENTED IN THE LEGISLATURE OF THE STATE OF KOROR DO ENACT AS FOLLOWS:

1           Section 1.     **Short Title.** This Act shall be known and may be cited as the  
2           “Supplemental State Budget Act for 2008”.

3           Section 2.     **Appropriation.** The sum of \$72,000.00 is hereby authorized and  
4           appropriated for expenditures and obligations in Fiscal Year 2008 from Koror State Treasury to  
5           the budget activity specifically itemized in the attached Schedule A which is incorporated  
6           herein by reference.

7           Section 3.     **Revenue Sources.** The entire sum of \$72,000.00 herein authorized and  
8           appropriated for Koror State FY 2008 Supplemental Budget shall come from State's local  
9           revenues as identified in the attached Schedule B. If collection exceed projected revenues, all  
10          such excess collections shall remain in the Koror State Treasury until authorized and  
11          appropriated by law.

12          Section 4.     **Legislative Branch.** The sum of \$5,000.00 is hereby authorized to be  
13          appropriated and is appropriated for expenditure or obligation for FY 2008 for the purpose of  
14          covering expense of Koror State Legislature. The total amount appropriated shall be  
15          apportioned and allotted at the direction of the Speaker of the Koror State Legislature and shall  
16          be allocated according to the following schedule. The Speaker is hereby authorized to  
17          reprogram funds from one item to another within the legislative budget, but not to exceed  
18          15% of the total amount apportioned for the item which the funds are moved.

19	a. Legislative Travel (Fiduciary conference) .....	\$ 5,000.00
20	Sub Total .....	\$ 5,000.00

1           Section 5.     **State's Programs and Special Projects.** The sum of \$67,000.00  
2 supplemental fund is hereby authorized and appropriated for expenditures and obligations  
3 for Fiscal Year 2008 to cover additional expenses of the *Committee on The Silver*  
4 *Anniversary of Koror State Constitution*. The Governor is authorized to reprogram funds  
5 from one item to another but not to exceed 15% of the total amount apportioned for the item  
6 which the funds are moved. The total amount appropriated shall be apportioned and allotted  
7 at the direction of the Governor and shall be allocated according to the following schedule:

8     1. Committee on The Silver Anniversary

9           a. Luncheon (Option 1 ) .....	\$ 30,000.00
10          b. Media.....	\$ 5,000.00
11          c. Overtime for State employees.....	\$ 32,000.00
12                      Sub-total.....	\$ 67,000.00

13           Section 6.     **Severability.** If any part or provision of this Act is determined to be  
14 unlawful or invalid, such invalidity may be stricken and shall not affect the other provisions  
15 of this Act.

16           Section 7.     **Effective Date.** This Act shall take effect upon its becoming law by  
17 operation of the Koror State Constitution.
