KOROR MUNICIPAL ORD. NO. 177-80

AN ORDINANCE TO APPROPRIATE THE SUM OF \$165,966.55 FOR THE OPERATIONS

OF THE KOROR MUNICIPAL GOVERNMENT FOR FISCAL YEAR 1981.

## BE IT ORDAINED BY THE KOROR MUNICIPAL COUNCIL that:

Section 1. <u>Appropriation</u>. There is appropriated out of the Treasury of the Koror Municipal Government the sum of One hundred

sixty-five thousand nine hundred sixty-six and fifty-five cents (\$165,966.55) or so much thereof as may be necessary, for the operation of the Koror Municipal Government for Fiscal Year 1981 to be apportioned according to the following schedule:

1.	Administrative Salaries	\$ 72,000.00
2.	Legal Fee and Temporary Hires	22,313.40
3.	Chiefs Honoraria	5,400.00
4.	Councilmen's Compensation	9,600.00
5.	Social Security & Insurance	1,700.00
6.	Travel and Transportation	5,000.00
7.	Office Equipments	4,640.00
8.	Office Supplies	4,313.15
9.	Building Repair & Renovation	15,000.00
10.	Representation Fund	5,000.00
11.	Election Expenses	1,000.00
12.	Vehicle and Fuel	19,500.00
13.	Miscellaneous	500.00

This amount so allocated and apportioned above shall be subject to

the reallocation at the direction and upon written authorization of

the Mayor, provided, however, that such reallocation from one

to another shall not exceed 15% of the total sum allocated to the  $\,$ 

item or items from which such reallocation is made, and not in conflict with any other law or ordinance In force.

Section 2. Administration and Expenditure of Funds. The sum appropriated herein shall be administered and expended by the Mayor for purposes herein specified; provided, however, that the Budget and Finance Officer shall first make certification as to the availability of funds.

Section 3. Reporting Date. The Mayor of the Koror Municipal Government shall be responsible to ensure that the funds are expended only for the purposes for which they were appropriated. The Mayor shall prepare and submit to the Koror Municipal Council a report on all of the expenditures made against the funds herein appropriated on or before July 20, 1981 or upon completion or discontinuation of project or program funded, whichever is earlier.

Section 4. Reversion Date. The funds appropriated by this ordinance or any balance thereof which may remain unobligated or unexpended by June 30, 1981 or upon completion or discontinuation of the project or program funded herein, whichever is earlier, shall automatically revert to the Treasury of the Koror Municipal Government.

Section 5. All previous budget and amendments thereto are hereby revoked and superseded upon enactment of this ordinance.

Section 6. <u>Effective Date</u>. This Ordinance shall take effect on July 1, 1980 upon its approval by the District Administrator or upon its becoming law without such approval.
