MUNICIPAL ORDINANCE NO. 13-1959

AN ORDINANCE MAKING APPROPRIATION AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING JULY 1, 1959 AND ENDING JUNE 30, 1960, AND EVOKING AND SUPERSEDING ALL PREVIOUS ORDINANCE TO PROVIDE APPROPRIATION, EXPENDITURES AND AMENDMENTS THERETO.

WHEREAS Article VII of the Charter of the Municipality of Koror provides the power to make budget and the collection, disbursement and care of funds by ordinance, and

WHEREAS Municipal Ordinance No. 12-1959, in accordance with article VI of the Charter, provides assessment and collection of taxes, license fees, and other fees.

NOW THEREFORE BE IT ENACTED by the Council of the Municipality of Koror, that the aggregate sum of fourteen thousand two hundred and seventy-seven dollars and fifty three cents (\$14,277.53), or so much thereof as may be necessary, is hereby appropriated from current revenue together with any cash balance at the end of Fiscal Year 1959 for expenditure by the Municipality of Koror for the purposes hereinafter stated and subject to conditions hereinafter set forth, during the fiscal year beginning July 1, 1959 and ending' June 30, 1960:

Section 1. The sum of \$3,000.00 shall be set aside for administrative salaries to be paid as follows:

Section 2. The sum of \$1,380.00 shall be set aside for the honorarium of chiefs, councilmen and congressmen to be paid as follows:

- Section 3. The sum of \$30.00 shall be set aside for the purchases of administration stationery and office supplies.
- Section 4. The sum of \$150.00 shall be set aside for the rental of boats and vehicles for use on official business.
- Section 5. The sum of \$50.00 shall be set aside for election expense.
- Section 6. The sum Of \$150.00 shall be set aside to meet expense for planting trochus in various sanctuaries.
- Section 7. The sum of \$7,500.00 shall be set aside for the construction of new municipal office building.
- Section 8. The sum of \$22.45 shall be set aside for the charter day expense.
- Section 9. The sum of \$1,995.08 shall be set aside for the purchases of elementary school stationery, office supplies and equipment.

BE IT FURTHER ENACTED that all previous appropriation and expenditures ordinance and amendment thereto of the municipality of Koror in conflict with the provisions contained herein are hereby revoked and superseded by this ordinance.

PASSED by two-third (2/3) majority affirmative vote of the Municipal Council of Koror.
