MUNICIPAL ORDINANCE NO. 19B-61

AN ORDINANCE TO ESTABLISH THE NAMES AND BOUNDARIES OF THE
SEVERAL
HAMLETS IN KOROR.

WHEREAS existing boundaries between the several hamlets in Koror
are
not clearly staked out, thereby causing confusion in the minds
of the
people regarding the proper boundaries; and

WHEREAS a situation exists where some of the hamlets are known
by more
than one names, thereby causing further confusion in this
respect;

NOW THEREFORE BE IT ORDAINED that:

There shall be established in Koror Municipality twelve (12)
hamlets
to be known as:

Further, the boundaries of these hamlets shall be as follows:

NGERMID: The western boundary of Ngermid shall correspond to
the road
from Rengrak Dock to Sansaro, continuing therefrom
along
Tibedul Stream to the mouth of said Stream at Ibai in
Ngeri-
yeleb.

NGERKESOUAOL: On the East along Tibedul Stream; westerly from
Sansaro

and following the Main Highway to the intersection between the Main Highway and the road to the Catholic Mission Cemetery, thence following the latter road through the center of said Cemetery and straight through to Ngerulngai Inlet.

NGERCHEMAI: On the North from Rengrak Dock and southerly along Rengrak Road to Sansaro, thence westerly along the Main Highway to the corner of the Main and the small road doing to Dirrechomtilou's house, thence northerly along this small road and straight through to the sea (Rechesengel's house and Miiko's house are outside the boundary of Ngerchemai).

YEBUKEL: From the western boundary of Ngerchermai at the intersection between the Main and the road to Dirrechomtilou's house and

westerly along the Main past Maris Stella School,
thence
northerly to the sea along the small path to Meyas
Inlet.

MEKETII: From Meyas Inlet and straight up to the Main Highway,
thence
westerly along the Main Highway to Meketii Abai,
thence
northerly to the sea following the small path between
Mariar
and Lebukos.

TNGERONGER: From Meketii Abai thence westerly along the Main
Highway
to the intersection in front of Masami's Store, thence
northerly from the intersection and straight to
Ikesiil In-
let.

MADALAI: From Ikesiil Inlet and southerly along the road to
Ikesiil,
crossing the Main Highway at the intersection near
Masami's
Store, continuing along the old Ngesekes road to the
point
where there is running water, then turning left and
straight
to the sea; from the point where the left turn is made
and following the boundary of Toribiong Uchel's lease
and Kato-
sang's lease, continuing along the path road between
Tewid
Boisek's house and Takashi's house, up the road to the
Hos-
pital, and proceeding behind the Hospital building
along the small path at Didrangmatel to the road to
Ngerbeched,
thence northerly along this road past Moded's house,
thence westerly to Ngeriltoel, and on to the sea.

NGERBECHED: The area south of the southern boundary of
Madalaii.

IKELAU: From the boundary of Madalaih at Ngesekes, thence northerly to the intersection near Masami's Store, thence easterly along the Main Highway to Ikelau, thence southerly to Chur Inlet.

IDID: The area between Ikelau and Ngerbeched and south of the Main Highway.

MIUNS: The old meuns shall be retained.

NGERKEBESANG: Shall be the old Ngerkebesang, and including Ngemelis and Ngerechong.

Further, that this ordinance shall become effective upon being approved by the District Administrator.

Passed by two-thirds (2/3) vote of the Municipal Council.
