MUNICIPAL ORDINANCE NO. 40-67

AN ORDINANCE ADOPTING A MUNICIPAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 1967 MD ENDING JUNE 30, 1968 AND REVOKING AND SUPERSEDING ALL PREVIOUS BUDGETS AND AMENDMENTS THERETO.

BE IT ORDAINED BY THE KOROR MUNICIPAL COUNCIL that:

Section 1. The Municipality of Koror hereby adopts the following budget for Fiscal Year 1968, beginning July 1, 1967 and ending June 30, 1968:
