MUNICIPAL ORDINANCE NO. 44-68

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 43-68 TO PROVIDE FOR RE-CLASSIFICATION OF CERTAIN BUSINESS LICENSES.

BE IT ORDAINED BY THE KOROR MUNICIPAL COUNCIL that:

Section 1. Section 1,c, 2 of Municipal Ordinance No. 43-68 shall be amended to read as follows:

"2) A license fee of forty (\$40.00) dollars for each Scrap metal collecting business. A scrap metal collecting Business shall include any commercial enterprise which Purchases or otherwise obtains ferrous and/or non-ferrous metals for the purpose of reselling the same to dealers Who ultimately will permit such metals to be recast or reshaped into new forms."

Section 2. Section 1, c, 4 of Municipal Ordinance No. 43-68 shall be amended to read as follows:

"4) A license fee of twenty (\$20.00) dollars for each of The following businesses:

Retail Store Class C
Fuel Stand or Gas Station
Sawmill
Auto Repair Shop
Restaurant
Bar-Restaurant
Bakery Shop
Fish Market
Photo Studio
Private Club Bar

"A license fee of twenty (\$20.00) dollars shall be imposed upon each taxicab, U-drive, boat rental, or charter boat business which operates no more than two vehicles for hire; a license fee of sixty (\$60.00) dollars shall be assessed if such business operates more than two but less than seven (7) vehicles; a license fee of one hundred (\$100.00) dollars shall be levied if such business operates more than six (6) but less than eleven (11) vehicles; a license fee of one hundred fifty (\$150.00) dollars shall be imposed if such business operates eleven (11) or more vehicles for hire. For the purpose of this section, a boat shall be considered a vehicle."

"A license fee of twenty (\$20.00) dollars shall be collected for each commercial bus operated in Koror."

"A license fee of twenty (\$20.00) dollars shall be collected for each commercial ferry boat operated in Koror."

Section 3. Section 2 of Municipal Ordinance No. 43-68 shall be amended to read as follows:

"Section 2. Class A, B and C retail stores are defined as follows:

"a. A class A retail store shall include any combined wholesale and retail business which sells general merchandise and alcoholic beverages in their original containers."

"b. A class B retail store shall include any combined wholesale and retail business which sells general merchandise but does not sell alcoholic beverages in their original containers."

"c. A class C retail store shall include any exclusively retail business which sells general merchandise whether or not including alcoholic beverages in their original containers. Businesses which are exclusively fish market, food markets or alcoholic beverage package goods distributors shall not be classified as Class C retail stores."

"d. A business which sells alcoholic beverages by the drink and not in their original container or, if beer, by the bottle or can to be drunk on the premises shall be licensed separately as a bar."

Section 4. This ordinance shall become effective according to the applicable provisions of Trust Territory Code Section 31.

PASSED BY a two-thirds (2/3) majority vote of the Koror Municipal Council on August 14th, 1968.
